WHY are you Engaging Providers?



- Define the role of the provider in the RETAIN participant
- What role does the provider serve at the following points of the participant's journey in RETAIN: enrollment, case management, and discharge?
- Is there a disconnect between the why, and what is communicated to providers?



What factors to consider in addressing barriers?

- Frequency of RETAIN participants engagement with provider
- Scope of practice differences between states
- Average wait times for appointments
- Provider incentive for wanting to participate in RETAIN
- Connecting with administration (office manager, director) versus providers
- Other characteristics:
 - Practice size
 - Years of experience
 - OPractice setting (e.g. hospital, stand-alone outpatient practice, etc.)ORural, urban, suburban



Analyzing Provider Engagement Pain Points

	Participant Journey Phase	What challenges occur here?	What strategies help (+) or hinder (-) progress with this challenge?
<i>Ex. Obtaining provider sign-off on RTW plan</i>	RTW Plan Development / Transition to Work	Long response time, providers have lower awareness of specific RTW plan terminology and accommodations	+Phone call followed by email or portal message documenting the discussion -Repeated email/portal messages




